LOCATION

The property fronts Kingstanding Road in a mixed retail and residential area close to the traffic light junction with Dyas Road and Hawthorn Road. Birmingham city centre is located approximately 5 miles to the south, via the A34. The property also provides easy access to the Midlands Motorway Network via Junction 7 of the M6, which is within approximately 3 miles.

DESCRIPTION

The premises comprise a three-storey mixed use detached building of brickbuilt construction surmounted by a flat roof. Internally the property consists of a vacant unit on the ground floor which benefits from a shop front, carpets, electric wall mounted heaters, plastered & painted walls, suspended ceiling, LED lights, a kitchenette and WC facilities.
