LOCATION

The property occupies a prominent position fronting the main B4100 Constitution Hill. The B4100 is a main arterial route leading into Birmingham City Centre and a 10 minute drive to Junction 1 of the M5 motorway. The historic St Pauls Square is within walking distance as is the City Centre. There are excellent transport links and local amenities within close proximity. The A38(M) is approximately 0.5 miles away which leads to the wider national motorway network.

DESCRIPTION

The property comprises a three storey mixed use building of brick built construction surmounted by a flat felt roof. The vacant accommodation is located on the second floor which is accessed via a stairwell to the side and can be used for a variety of uses (subject to planning). Internally the accommodation benefits from carpeted floors, suspended ceiling, fluorescent strip lighting, power points and WC facilities in the common area.
